## **Diamond Dressage Series Schooling Show**

**Date:** Saturday Sept 19th, 2020     **Judge:** Virginia Allen

**Entries Close:** Monday Sept 14th, 2020     **Ride times available:** Thursday Sept 17th, 2020

**Tests:** EC & HCBC offered.

**HCBC:** Membership to HCBC is required of both rider and horse owner. Please include photocopy with entry. HCBC rules to apply.

**Entries:** Close Monday at 5:00pm. May be dropped off in person, mailed, or scanned and sent via email. Entries must include all required information and payment.

**Ride Times:** Ride times will be available on Thursday PM. Once ride times are posted they are final. Those who request a time change after posting will be at discretion of Show Manager and will be charged \$10.00 + GST change fee.

**Late Entries/ Substitutions:** May be accepted at the discretion of the Show Office with a late fee of \$10.00 +GST. Substitutions may be accepted with 48 hrs notice to start of show.

**Ribbons/HP Award:** Classes will be grouped according to level. We offer ribbons to fifth and "High Point" awards for JR/YR, AA, Open, and FEI, divisions.

**Forms/Payment** No refunds after closing date.

**Show Arena:** High Point has one indoor and one outdoor arena; either may be used for tests the other to be used for warm up. Tests will be ridden in a 20 x 60 ring. Show arena will be closed for competition.

**Lunging:** Lunging is permitted in the round pen provided only.

**Competitor/ Equine Wear:** Allowed: boots, bandages, and headsets. Helmets and proper boots must be worn, neat attire expected. Helmets must be worn while riding on property at all times.

**Freestyle Music:** Music must be on a Bluetooth compatible device (e.g. iPhone). Rider must organize for someone to play music for them. Please contact the Show Office with any questions regarding music material.

**Show Office/ Facility Access:** Will only be available via text or email Due to Covid Restrictions.

**Food/ Beverage:** Closed at this Time due to Covid Restrictions, we may have some tea/coffee, Pastries outside

**Dogs:** Well behaved, leashed dogs (who leave no evidence) are welcome on the property. Dogs are not allowed in the Clubhouse or indoor arena.

**Trailer Parking:** Trailer Parking is available in the lot adjacent to HPEC; south side. Absolutely no trailer access during the day of the show. Trail access to the show grounds is available from the adjacent lot. Early or after-hours access to the show grounds can be arranged through the office.
